The rotation of this alternate list goes into effect on **Thursday, June 1, 2017 at 7:00 a.m.** local time. Until this time, if a non-exempt player withdraws from your Section, we will go to your Section's alternate list to replace them. After this time, we will consult the National Alternate List solely (above) to get the replacement player, regardless of how the player withdrawing secured a spot in the field. Remember, the **section owns** the spot on the NAL, it is not an individual player's spot. If an EXEMPT player withdraws at any time, or if a section exhausts their respective alternate list, we will consult the NAL right away.
